3. The contractors who want to submit the tenders should submit the same in a sealed envelope to the Chief Executive Officer (O) on or before 17/11/2023, 6 PM .
4. The tenders must be accompanied by a cheque/ demand draft or Rs 15,000/- being Earnest Money Deposit drawn in favour of Jalgaon Janata Sahakari Bank Ltd. Jalgaon. The Earnest Money Deposit shall be returned to the unsuccessful tenderer. The Earnest Money Deposit shall be converted to Security Deposit in case of the successful tenderer and the said amount will remain with the organization till satisfactory completion of the contract.
